AMENDMENTS TO SECTION 4 OF CUMBRIA CHESS ASSOCIATION CONSTITUTION (PROPOSED BY KESWICK CHESS CLUB):

4. (2) Club League Championships

--- AMENDMENT TO SUB-SECTION f) (in bold underscore)

f) Matches shall be *played in the week designated for each round of fixtures. Away teams have the choice of playing on the Saturday of the designated week or on the club night of the home team.*

--- NEW SUB-SECTION g

g) Rounds of fixtures to be played as follows (all dates to be confirmed by August 31):

- Round 1 during the third complete week of September;

- Round 2 during the second complete week of October;

- Round 3 during the fourth complete week of October;

- Round 4 during the third complete week of November;

- Round 5 during the second complete week of December;

- Round 6 during the second complete week of January;

- Round 7 during the first complete week of February;

- Round 8 during the final week of February/first week of March;

- Round 9 during the final week of March;

- Round 10 during the final week of April.

--- NEW SUB-SECTION h

h) When a club has two or more teams in the league, the B team and/or C team(s) match(es) in the round of fixtures shall be played in the week prior to or immediately following the A team's fixture if it is not possible to play the matches in the same week as the A team's fixture
